1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Private Canadian Mid Cap Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 — Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Results of Operations

For the six month period ended June 30, 2019 (the "period"), the Pinnacle Series units of the Fund generated a total return of 15.1%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Pinnacle Series units with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the S&P/TSX Composite Index, returned 16.2% during the same period. In accordance with National Instrument 81-106, we have included a comparison to broad-based index to help you understand the Fund's performance relative to the general performance of the market, but caution that the Fund's mandate may be significantly different from the index shown.

The Fund's relevant benchmark, the S&P/TSX Completion Index, returned 17.2% during the same period. We have included this comparison, which more closely reflects the market sectors and/or

asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund. Equity markets rebounded globally over the period after declining sharply in the fourth quarter of 2018. Market sentiment became more positive given the steep reset in corporate valuation levels and an expectation of continued economic expansion, albeit at a slower pace than had been forecasted. The U.S. administration pushed the U.S. Federal Reserve Board ("Fed") to consider decreasing interest rates, and the trade conflict between the U.S. and China escalated, driving market volatility.

Moderated economic growth expectations and a view toward more accommodative central bank policies resulted in a yield curve inversion, in which 10-year government bond yields fell below three-month yields. Yield curve inversion has often been a leading indicator of an economic recession occurring in the following year. However, this does not occur all the time, and equity markets have generally performed well in the late stages of the economic cycle.

The market continued to watch for signs of an improving trade environment and a more accommodative Fed acting as potential catalysts for improved corporate confidence and investment. Consumer confidence remained resilient, with employment data healthy in Canada and globally.

The Fund underperformed the relevant benchmark as a result of its lack of exposure to cannabis and gold equities, and to outperforming stock Shopify Inc.

Cannabis stocks drove about 200 basis points ("bps") of performance in the benchmark (about a 5% weighting in the benchmark). The Fund does not invest in these stocks because of their lack of cash flow and dividends and their high valuations. Gold stocks also contributed about 200 bps to the benchmark's performance (about an 8% weighting). The Fund does not invest in these stocks because of their poor long-term track record of returns and general lack of dividends. Shopify Inc. contributed about 175 bps to the benchmark's performance (an approximate 4% weighting before the stock graduated to the S&P/TSX 60 Index). Shopify Inc. does not pay a dividend, and we believe its valuation is very high.

Individual detractors from the Fund's performance included CES Energy Solutions Corp., which experienced increased multiple compression as smaller-capitalization energy services companies fell out of favour with investors. Cott Corp. declined on disappointing first-quarter 2019 results. We believe the valuations for both stocks remain attractive and that Cott Corp.'s issues are temporary.

An overweight position in the Industrials sector contributed to the Fund's performance, as did stock selection in the Energy sector. The Fund's Energy sector holdings outperformed those of the benchmark.

Boyd Group Income Fund was a top individual contributor to performance. The company benefited from continued organic growth, acquisitions and margin expansion. Badger Daylighting Ltd. benefited from disaster-related work. Gibson Energy Inc. is benefiting from higher differentials on Canadian heavy oil, as well as from its sale of non-core businesses.

The Fund remains balanced between more cyclical, economically sensitive holdings and more defensive, stable businesses, and we believe individual holdings are well positioned in their industries. During the period, we added Brookfield Business Partners L.P. to the Fund. The company participates in the private equity investments made by Brookfield Asset Management Inc. that are focused on business services and industrials, which have historically achieved strong investment returns. We believe the company should benefit from the positive outlook of its portfolio holdings (including some strong new investments made), and the stock was trading well below our conservative estimate of net asset value.

We also added Superior Plus Corp., a large North American propane distributor. In 2018, Superior Plus Corp. acquired NGL Propane, LLC, giving the company a platform and scale in the attractive northeast U.S. heating market, which was a natural extension given its high market share concentration in Canada. We believe Superior Plus Corp. has many positive attributes, including lower economic sensitivity, robust expansion opportunities, and a favourable dividend yield, payout and valuation.

We increased the Fund's position in Whitecap Resources Inc. by selling Vermilion Energy Inc., based on each stock's relative valuation and outlook. Vermilion Energy Inc., has been a relative outperformer for a Canadian-listed exploration and production company, and we believe Whitecap Resources Inc. offers better value.

The Fund's net asset value increased to \$147.1 million at June 30, 2019, from \$117.6 million at December 31, 2018. This change was composed of investment performance of \$18.5 million and net sales of \$11.0 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia

Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

$Related\ Brokerage\ Commissions$

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital Inc. or other related dealers in whom Scotiabank has a significant interest (a "Related Broker"). These Related Brokers may earn commission or spreads on such transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$977 in commissions to Related Brokers.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the

Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 — Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Carol S. Perry (Chair), Stephen J. Griggs, Simon Hitzig, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The main components of compensation are an annual retainer and a fee for each committee meeting attended. The chair of the IRC is entitled to an additional fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Fund received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;

- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Fund relied on IRC standing instructions regarding related party transactions during the period.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.


The management fee for this series is negotiated and paid directly by these unitholders and not by the Fund.





A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.
