1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Wealth U.S. Value Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 — Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Results of Operations

For the six-month period ended at June 30, 2024 (the "period"), the Pinnacle Series units of the Fund generated a total return of 2.1%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Pinnacle Series with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the S&P 500 Index (C\$) returned 19.2% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market, but caution that the Fund's mandate may be significantly different from the indices shown.

The Fund's relevant benchmark, the Russell 1000 Value Index (C\$) returned 10.2% during the same period. We have included this comparison, which more closely reflects the market sectors and/or

asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund.

Equity market performance continued to be narrowly led by a handful of stocks, with NVIDIA Corp. alone accounting for nearly one-third of the total return of the S&P 500 Index year to date. The Information Technology and Communication Services sectors continued to dominate performance by wide margins. The Russell 1000 Growth Index nearly tripled the returns of the Russell 1000 Value Index year to date.

The Fund underperformed the relevant benchmark as a result of security selection in the Consumer Staples and Consumer Discretionary sectors and an underweight exposure to the Communication Services sector.

Stock selection in the Consumer Staples and Consumer Discretionary sectors detracted from the Fund's performance. An underweight allocation to the Communication Services sector and overweight allocation to the Health Care sector also detracted from performance. The largest individual detractors from performance included holdings in Dollar General Corp. and CVS Health Corp. Dollar General exceeded consensus earnings expectations and either maintained or increased its full-year forecast in its most recent report. Still, its stock sold off during the period. CVS Health reported disappointing performance despite the company's optimistic 2024 outlook at its December Investor Day. Unfortunately, management mis-estimated its medical loss ratio and the anticipated profitability in its book for Medicare Advantaged lives.

Stock selection within the Industrials sector contributed to the Fund's performance, as did a lack of exposure to the Utilities sector. Top individual contributors to performance were holdings in W.W. Grainger Inc. and Microchip Technology Inc. W.W. Grainger has executed well, but recent commentary around a slowing maintenance, repair and operations market may lead its shares to underperform in the near term. Microchip Technology continued its discipline of returning increasing amounts of free cash flow to shareholders, all funded by improving profitability. The company recently reduced its debt and its balance sheet is strong.

New holdings in Air Products and Chemicals Inc., Keurig Dr Pepper Inc. and Constellation Brands Inc. were added to the Fund during the period. Air Products and Chemicals was purchased for its stable business model and strategy of capitalizing on energy transition, which should play out over many years. Its dividend has been increased for 42 consecutive years. Keurig Dr Pepper was added based on its attractive category exposures across different customer needs and emerging offerings in sports hydration and energy drinks. Its international division is an emerging growth driver and has seen strong revenue growth since 2018, with exposure primarily coming from Mexico and Canada, which are two markets that grow in line with or better than the U.S. market. A new holding in Constellation Brands, the third-largest beer company in the U.S., was also added. Beer growth is expected to continue in the 7%–9% range, driven by distribution, demographics and innovation.

Existing Fund holdings in The Walt Disney Company, Service Corp. International, Abbott Laboratories, Amgen Inc. and

UnitedHealth Group Inc. were increased based on their risk-reward potential.

Perrigo Company PLC, CVS Health Corp. and Conagra Brands Inc. were eliminated from the Fund. Perrigo Company was sold as its new management team has not lived up to its word on the remediation costs and timeline for its infant formula business. On its fourth-quarter 2023 earnings call, management spoke to further investments required in the infant formula business that would likely result in 2024 earnings being relatively unchanged. Due to recent acquisitions and the need for debt reduction, Perrigo does not have the ability to take advantage of the stock price decline to repurchase shares. CVS Health was eliminated after a disappointing quarterly earnings report in which the medical loss ratio deteriorated, when management had been optimistic about this important margin driver to improve. This triggered a position paper violation as the fix to this trend will take much more time to correct. The Fund's position in Conagra Brands was sold in favour of the new holding in Constellation Brands, which has seen more revenue and earnings consistency.

Holdings in Ross Stores Inc. and W.W. Grainger were trimmed based on valuation.

The Fund's net asset value decreased to \$177.1 million at June 30, 2024, from \$184.5 million at December 31, 2023. This change was composed of net redemptions of \$11.4 million and investment performance of \$4.0 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related

parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 — Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder

approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;

- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without

taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.






